1. The main purpose of compiling this Monthly Bulletin is to show the general situation of Changhua county. It is intended to provide data for decision-making.
2. The measure units used in this Monthly Bulletin are of metric system and the currency unit is N.T.\$. If the figures in the table are long, we lift the unit count 5 and higher fractions as units and disregarding the rest. Therefore the total number doesn't always coincide with the detail number.

 - ”...” means figures not yet available.
 - ”0” means figure is below half a unit.
 - ”--” means figure provided are meaningless.

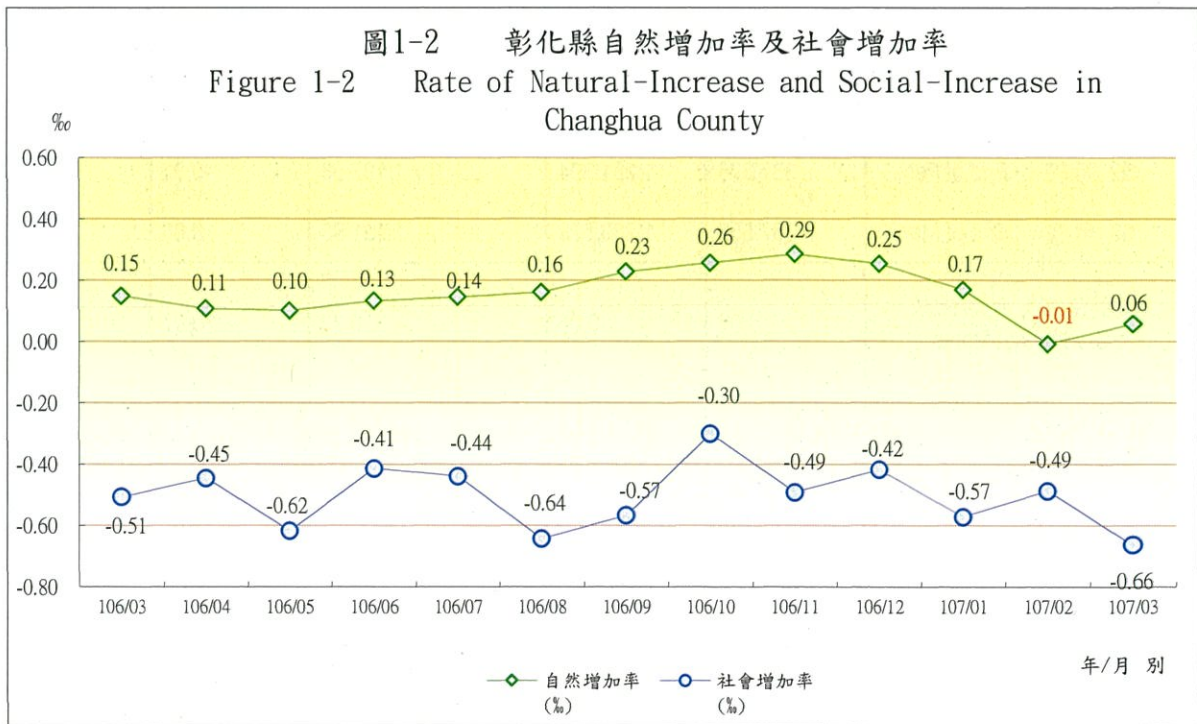
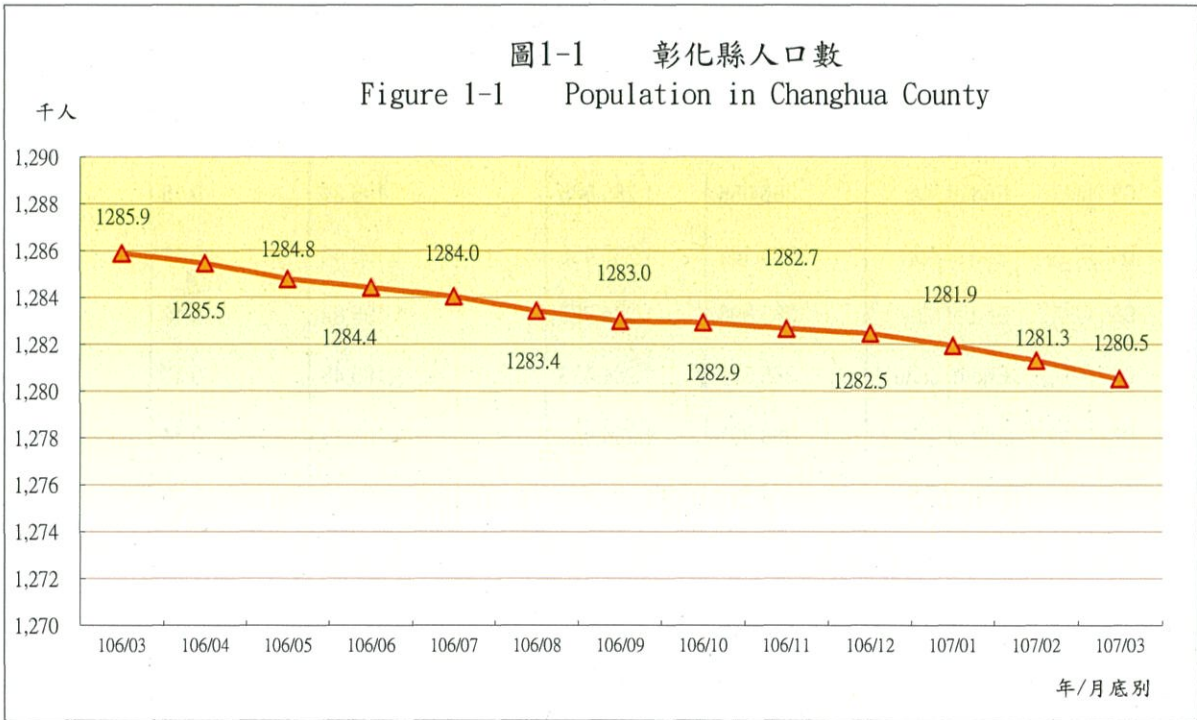

二、商業登記

本縣107年3月底之商業登記家數及資本額分別為36,060家及7,861,490千元，與上月底比較，分別增加0.22%及0.33%。

各行業中以批發及零售業20,649家，約占57.26%最多，製造業4,572家，約占12.68%次之。而資本額亦以批發及零售業3,231,808千元，約占41.11%最多，製造業1,541,000千元，約占19.60%次之。

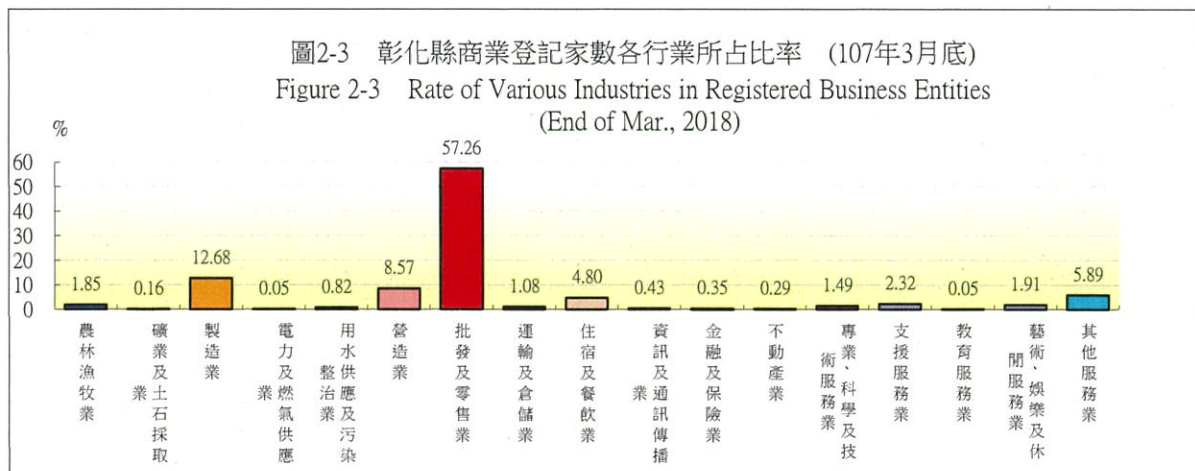
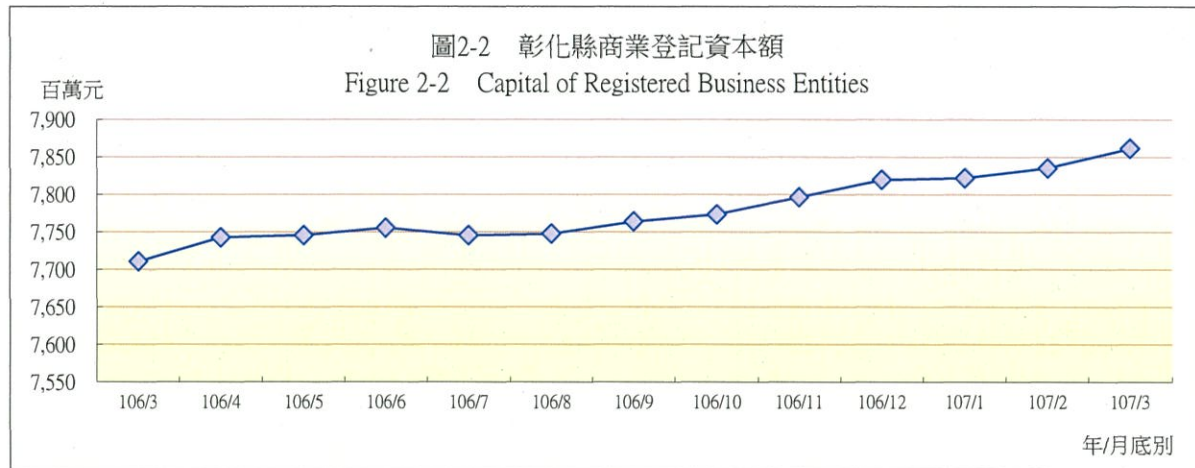
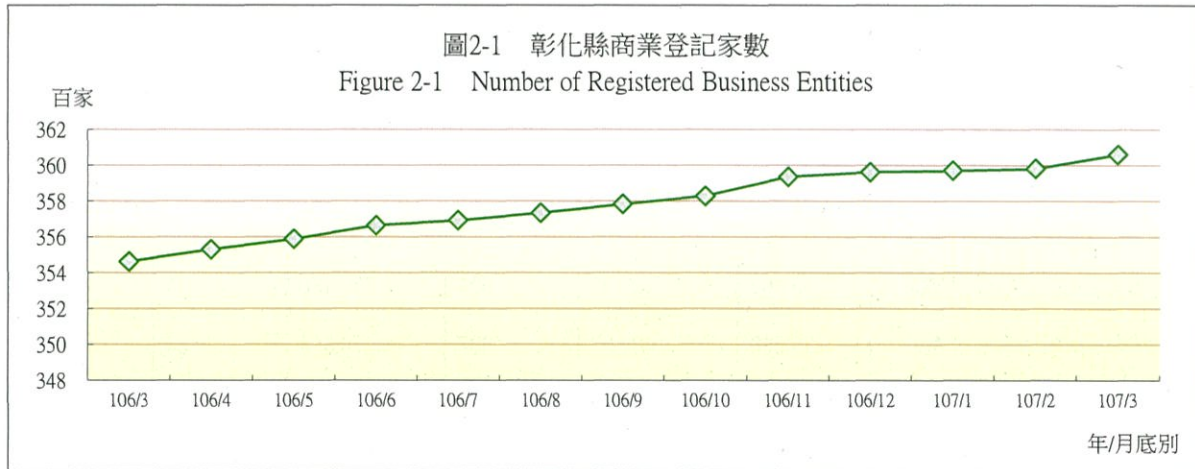

三、工廠登記

本縣107年3月底工廠登記家數為10,403家，與上月底比較，登記家數增加0.23%。

各行業中以金屬製品製造業3,794家，約占36.47%最多；紡織業及塑膠製品製造業皆為1,011家，約占9.72%次之。

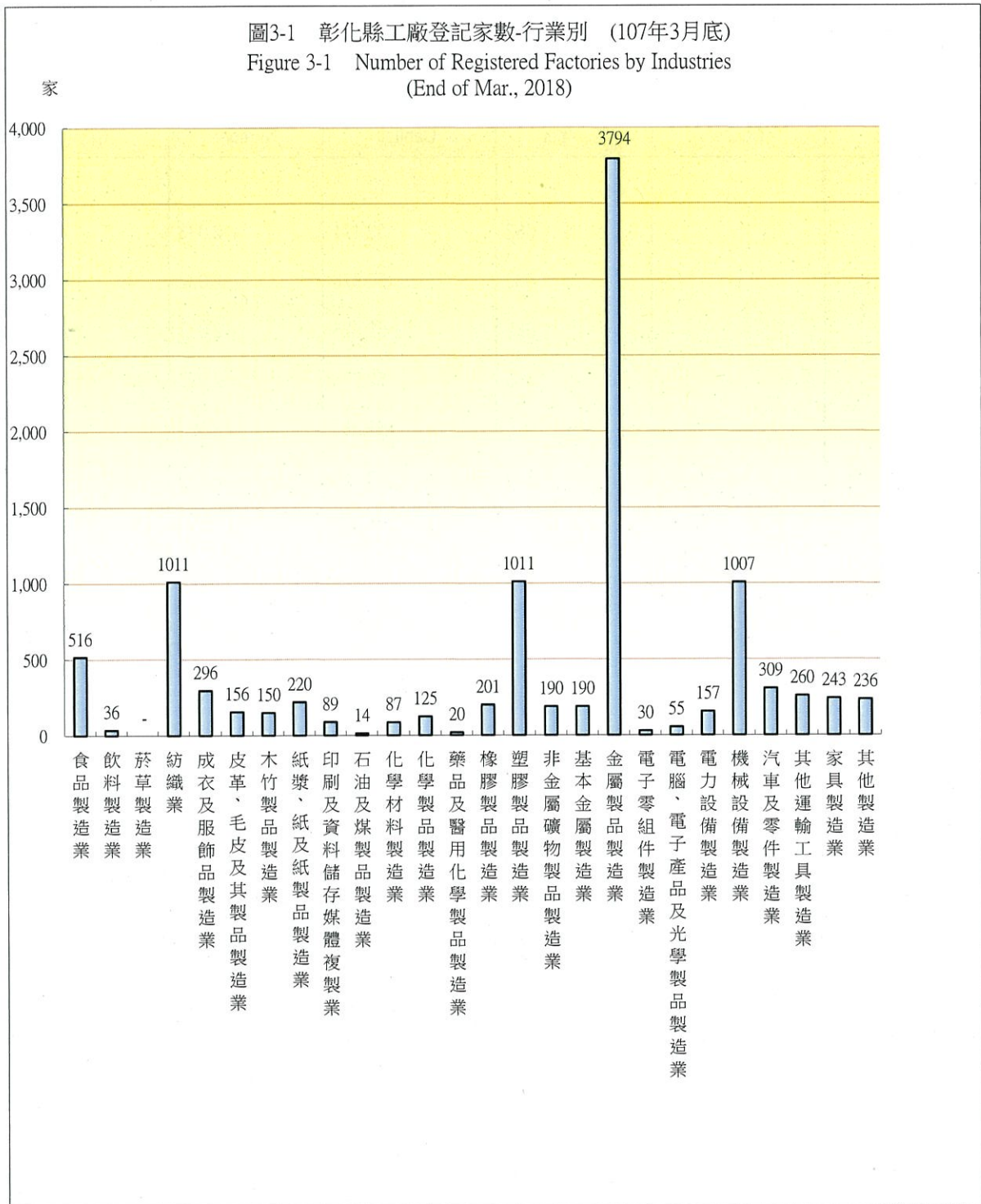


圖3-2 彰化縣工廠登記家數
Figure 3-2 Number of Registered Factories

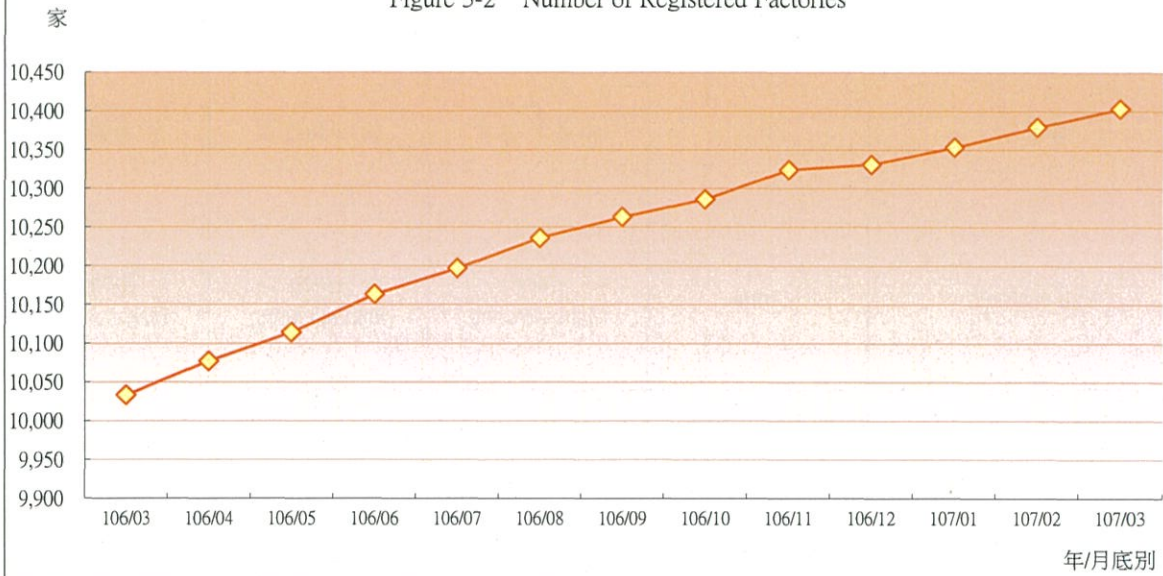


圖3-3 彰化縣工廠登記家數各行業所占比率 (107年3月底)
Figure 3-3 Rate of Various Industries in Registered Factories (End of Mar., 2018)

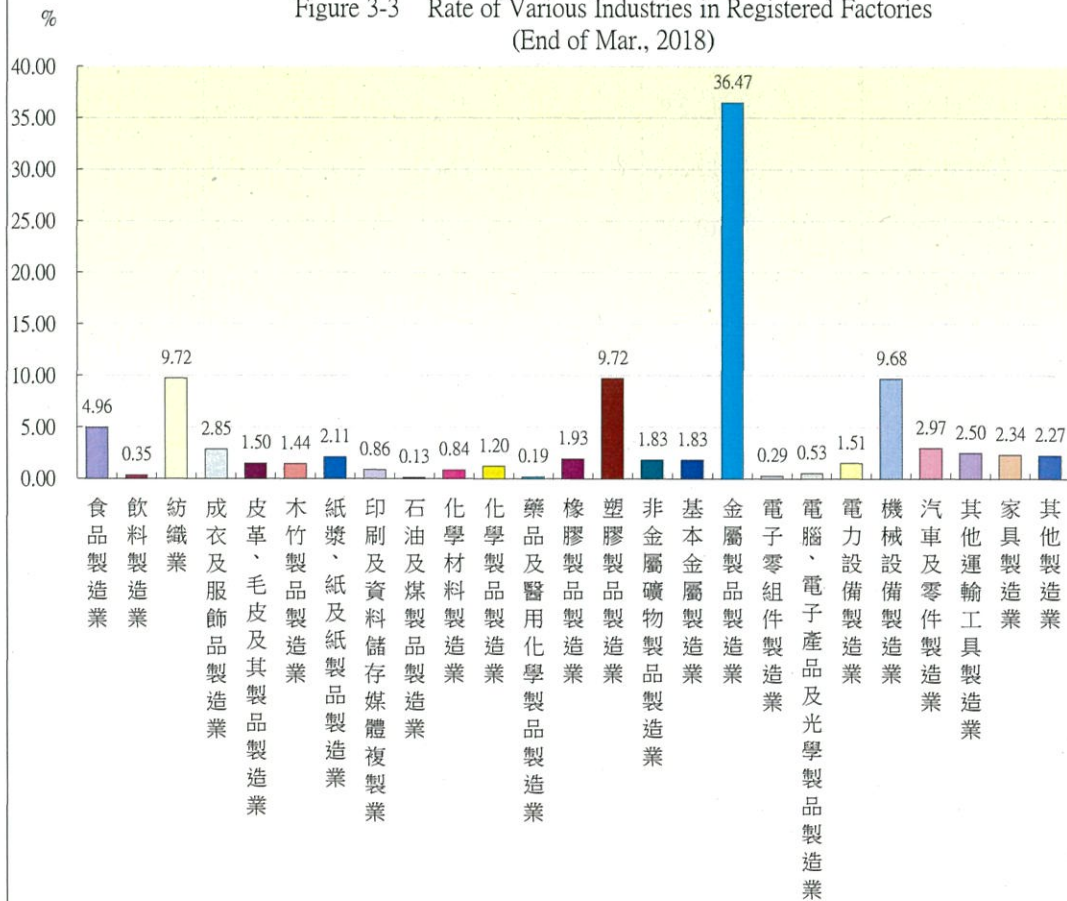
