1. The main purpose of compiling this Monthly Bulletin is to show the general situation of Changhua county. It is intended to provide data for decision-making.
2. The measure units used in this Monthly Bulletin are of metric system and the currency unit is N.T.\$\$. If the figures in the table are long, we lift the unit count 5 and higher fractions as units and disregarding the rest. Therefore the total number doesn't always coincide with the detail number.
3. The following symbols are used for tables:
  - ”-” means zero or not available.
  - ”...” means not yet published.
  - ”0” means less than a half unit.
  - ”--” means meaningless.
4. The figures given in this issue may not agree with the corresponding figures in the previous issue. The figures given in this issue is correct.

## 二、商業登記

本縣109年6月底之商業登記家數及資本額分別為38,413家及84億8,422萬元，與上月底比較，分別增加0.32%及0.39%。

各行業中以批發及零售業21,259家，約占55.34%最多，製造業4,962家，約占12.92%次之。而資本額亦以批發及零售業33億9,449萬元，約占40.01%最多，製造業16億7,472萬元，約占19.74%次之。

### 三、工廠登記

本縣109年6月底工廠登記家數為10,273家，與上月底比較，登記家數減少7.10%。【備註：工廠登記家數包含臨時工廠，臨時工廠之換照作業於109年6月2日到期，依照業者登記狀況，6月底之家數較上月減少較多。】

各行業中以金屬製品製造業3,973家，約占38.67%最多；塑膠製品製造業975家，約占9.49%次之。

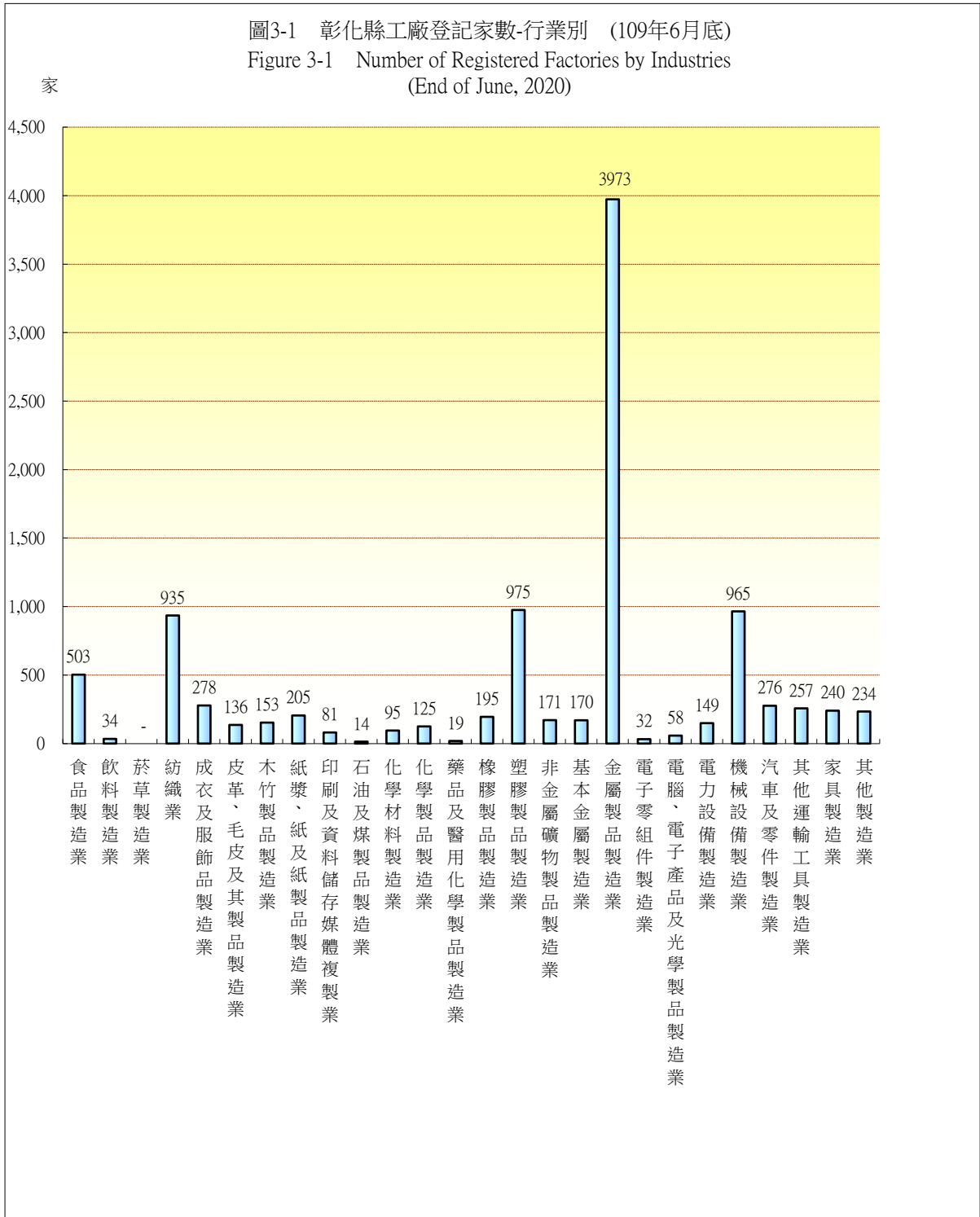


圖3-2 彰化縣工廠登記家數  
Figure 3-2 Number of Registered Factories

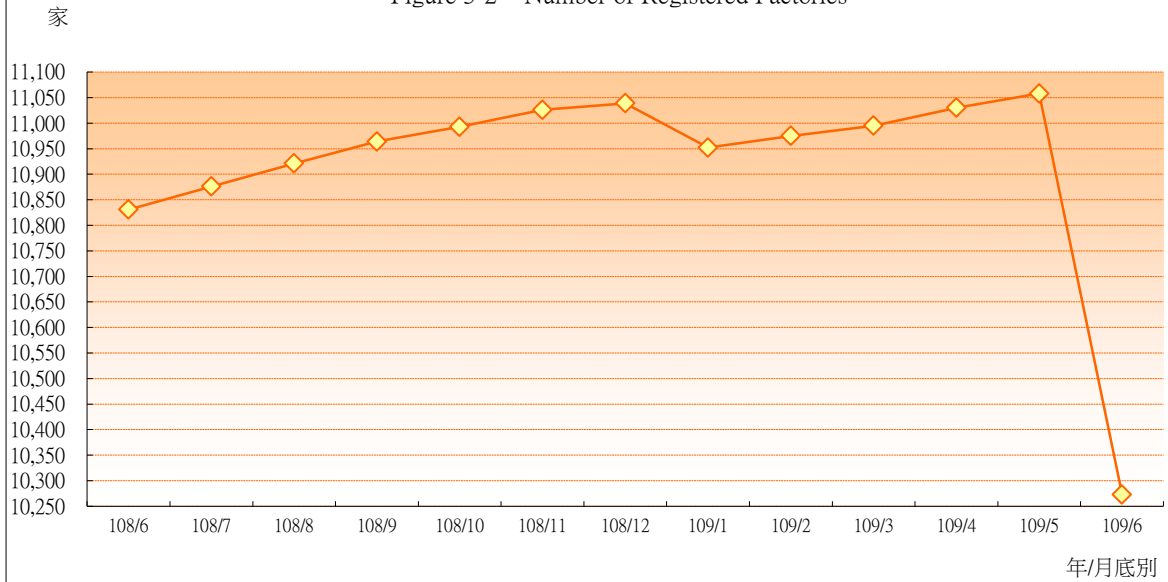
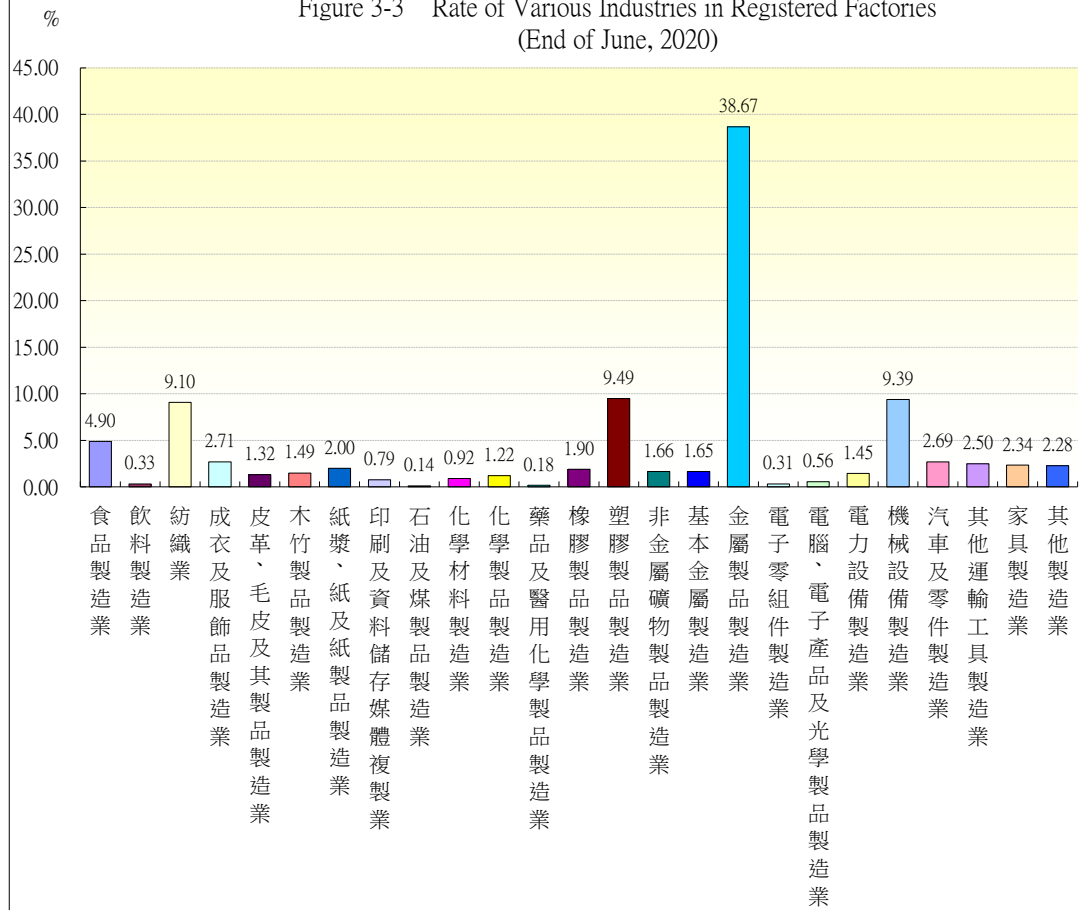


圖3-3 彰化縣工廠登記家數各行業所占比率 (109年6月底)

## 八、資源回收

本縣109年5月份資源回收共計2萬4,480公噸，其中以紙類8,686公噸最多，約占35.48%。

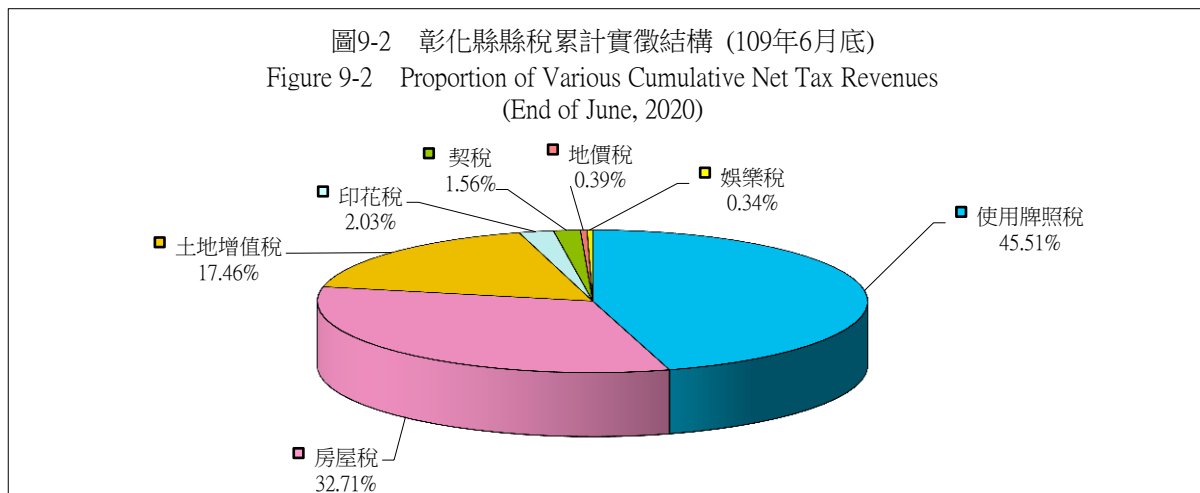
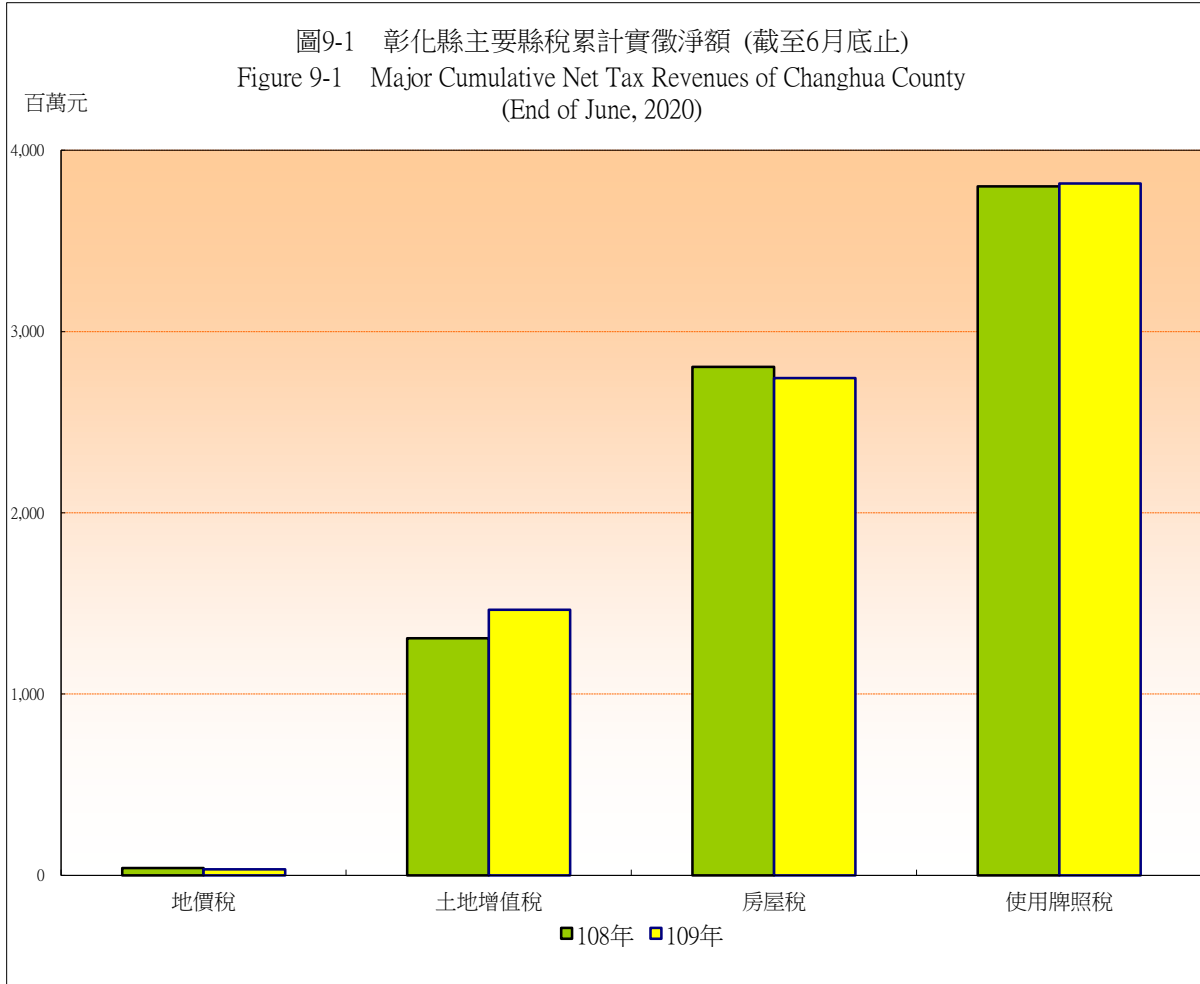

## 九、稅捐徵收

截至109年6月底止，本縣縣稅之實徵淨額為83億8,722萬元，累計徵收率（累計實徵淨額/累計分配預算數）為110.85%，實徵淨額較上年同期增加8,991萬元(或1.08%)。累計實徵淨額以使用牌照稅38億1,744萬元，約占45.51%最多；房屋稅27億4,340萬元，約占32.71%次之；土地增值稅14億6,454萬元，約占17.46%再次之。
