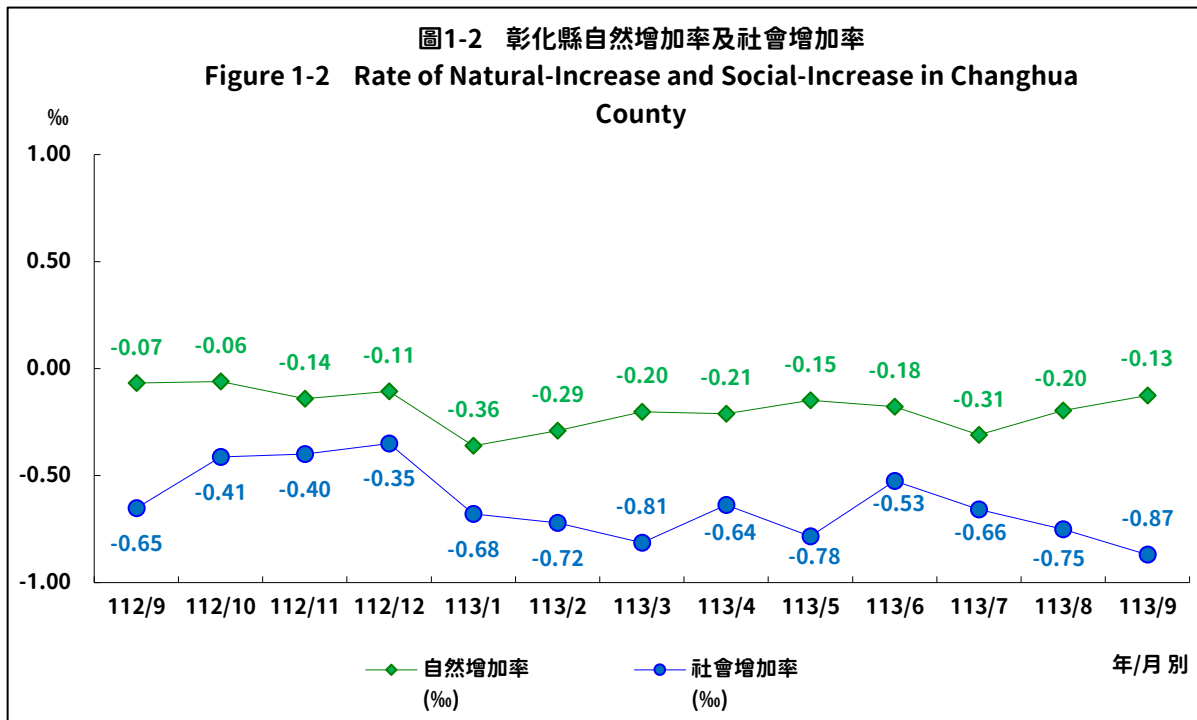
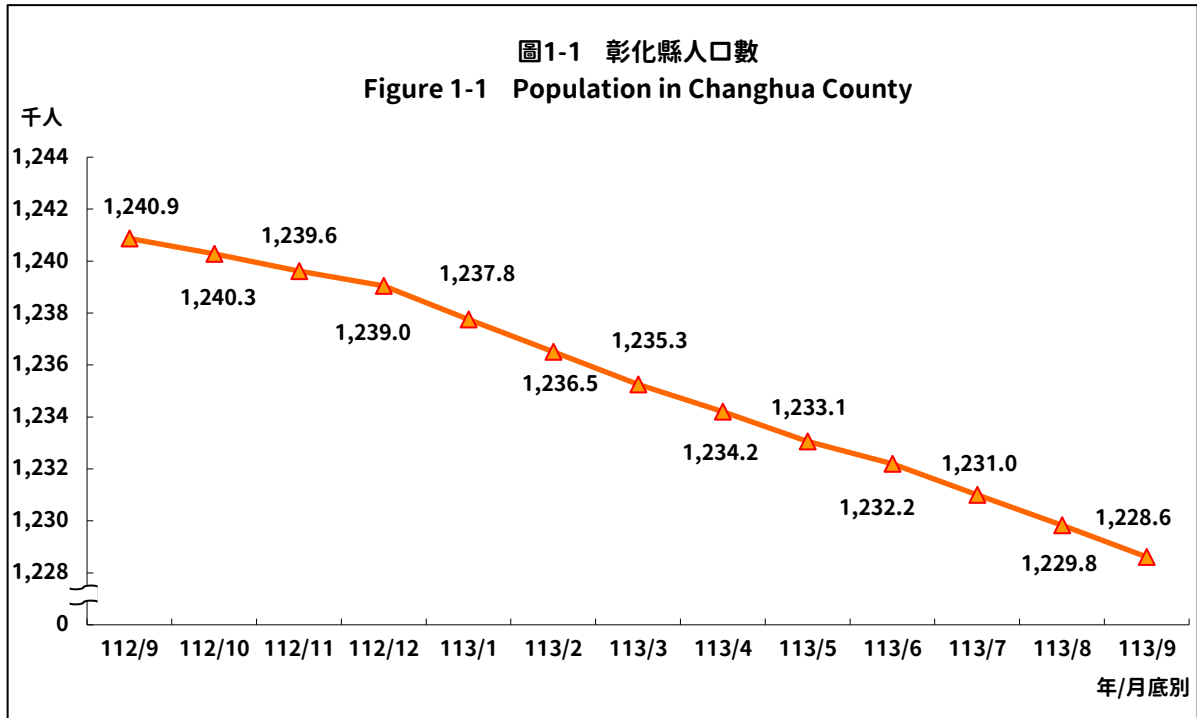

二、商業登記

本縣113年9月底之商業登記家數及資本額分別為44,005家及101億2,424萬元，與上月底比較，分別增加0.08%及0.21%。

各行業中以批發及零售業22,630家，約占51.43%最多，製造業5,881家，約占13.36%次之。而資本額亦以批發及零售業39億1,315萬元，約占38.65%最多，製造業20億6,599萬元，約占20.41%次之。

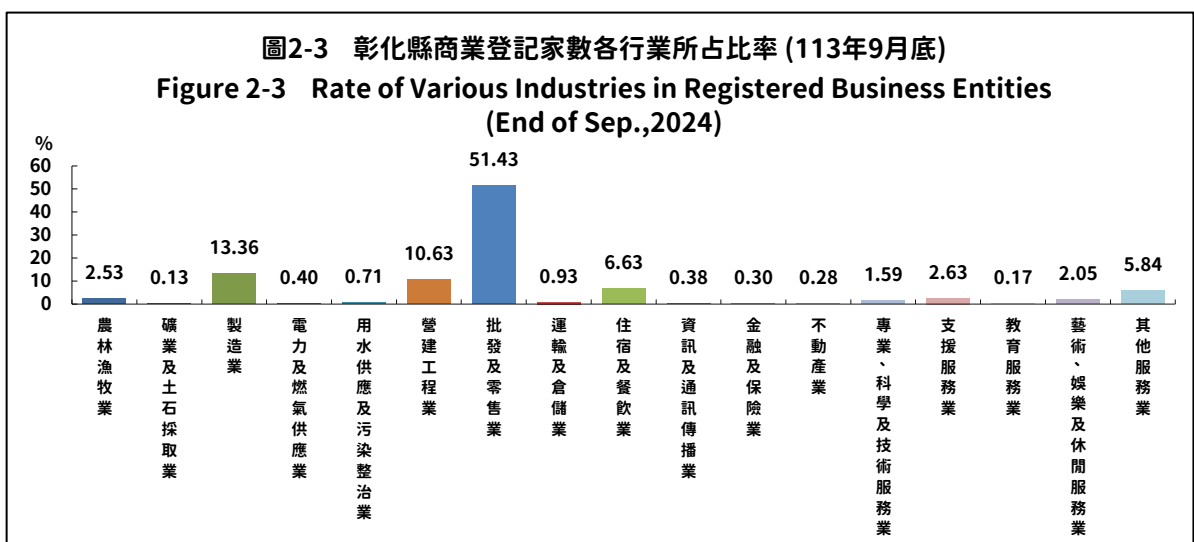
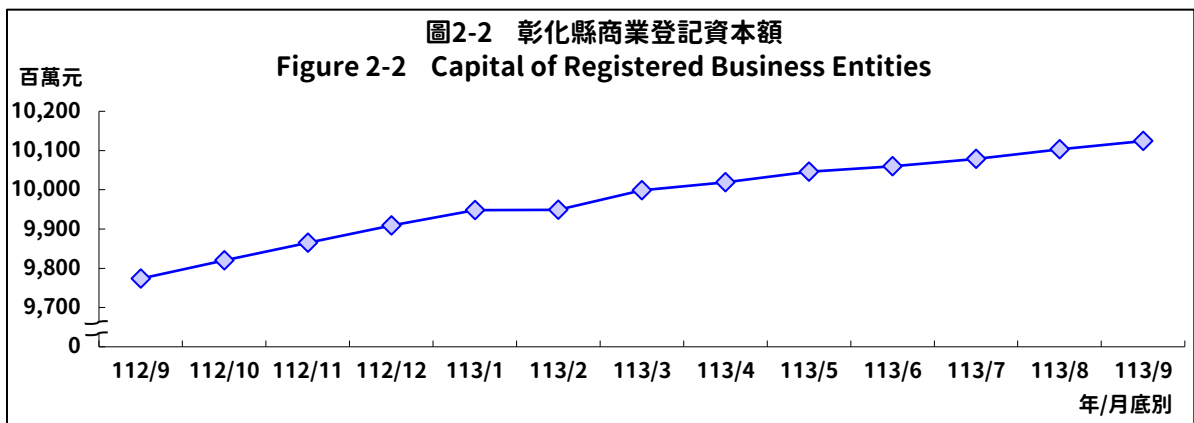
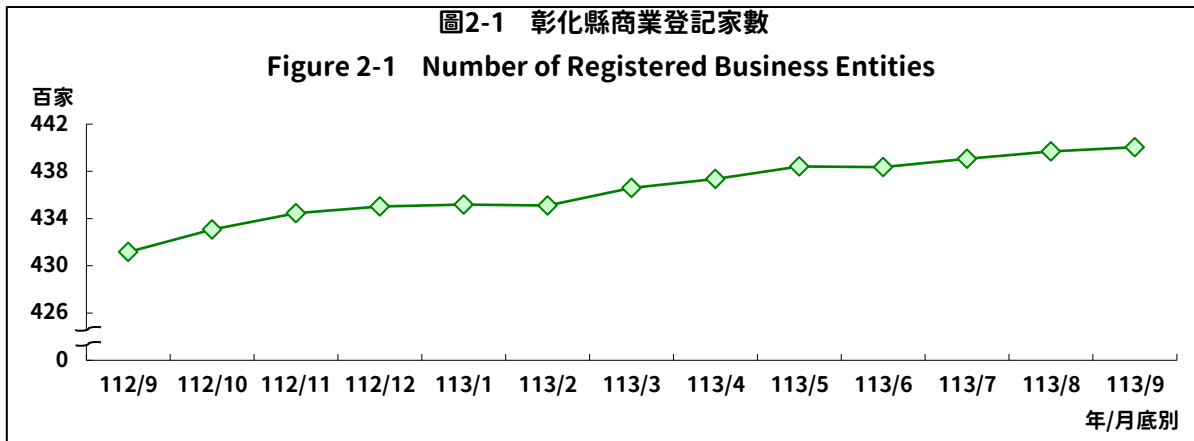

各行業中以金屬製品製造業5,448家，約占42.03%最多；塑膠製品製造業1,193家，約占9.20%次之。



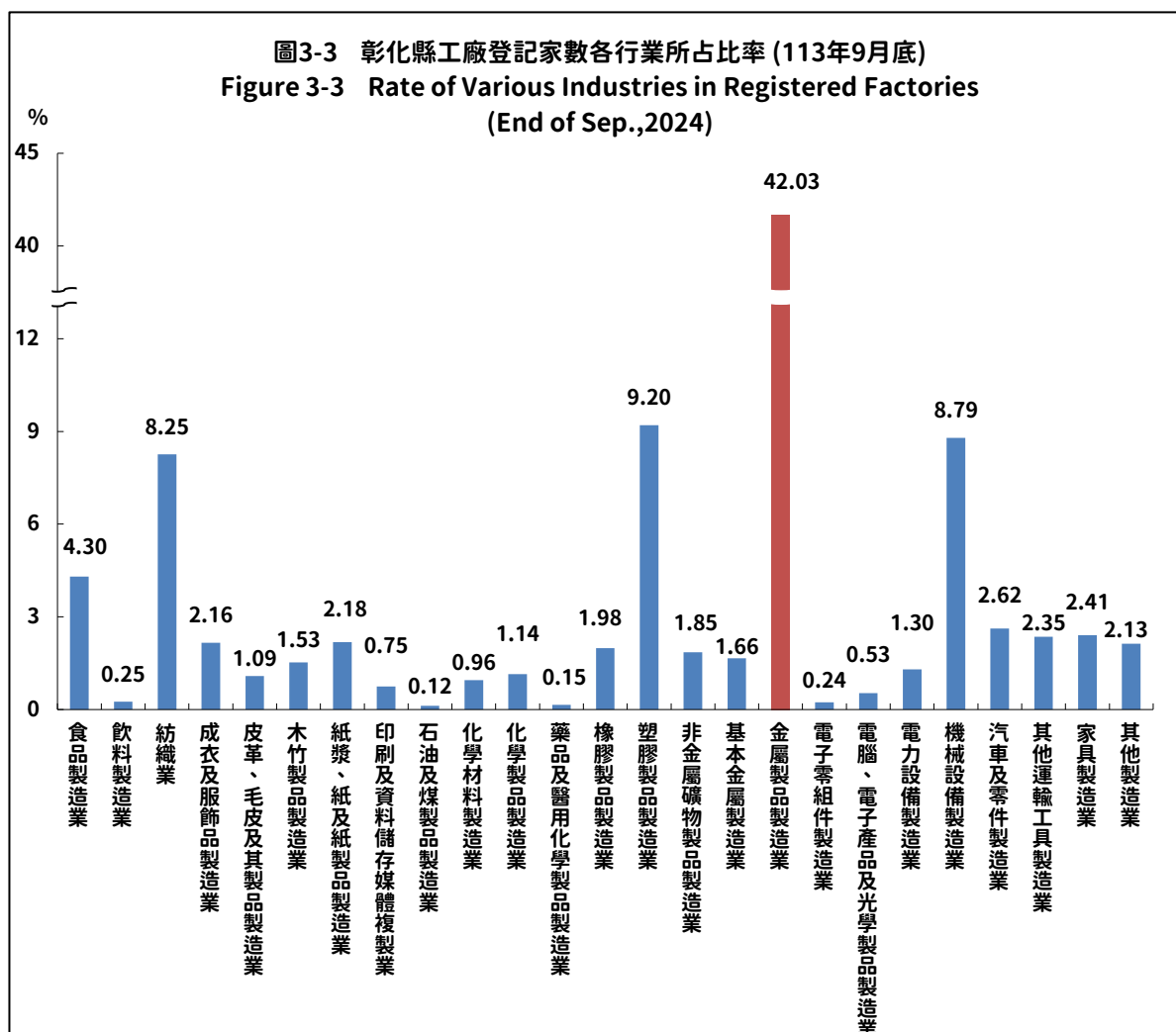
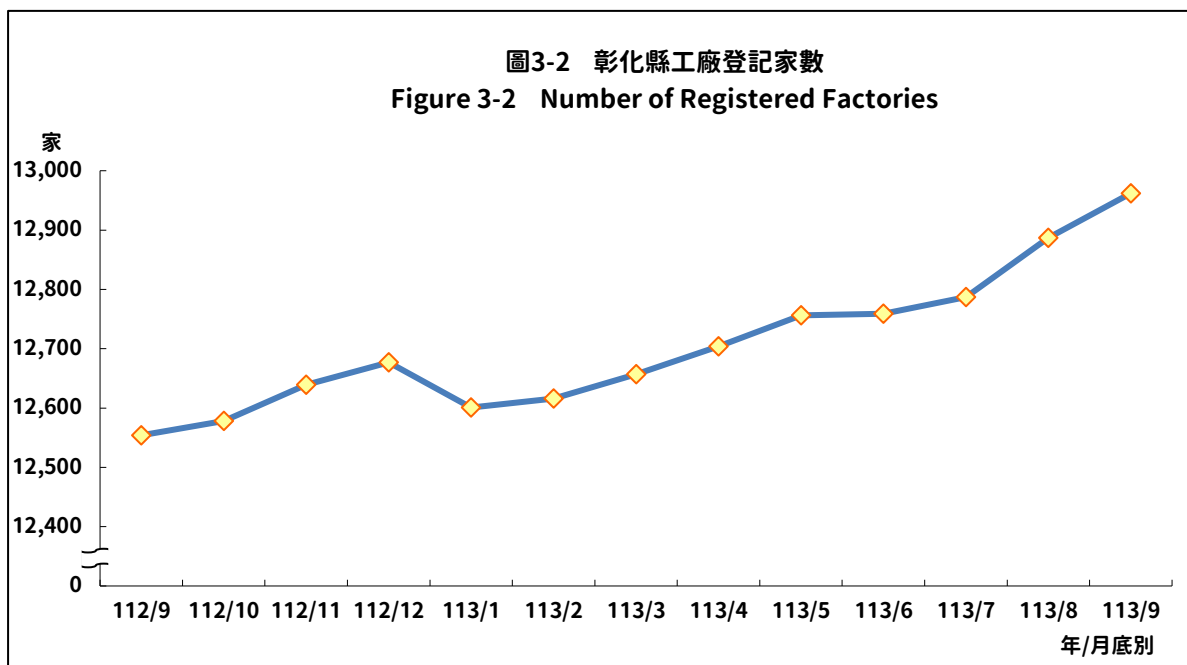

八、資源回收

本縣113年8月份資源回收共計3萬111公噸，其中以紙類9,733公噸最多，約占32.32%。

九、稅捐徵收

截至113年9月底止，本縣縣稅之實徵淨額為92億8,367萬元，累計徵收率（累計實徵淨額/累計分配預算數）為113.38%，實徵淨額較上年同期增加3億6,599萬元(或4.10%)。累計實徵淨額以使用牌照稅39億5,258萬元，約占42.58%最多；房屋稅31億5,017萬元，約占33.93%次之；土地增值稅13億7,453萬元，約占14.81%再次之。

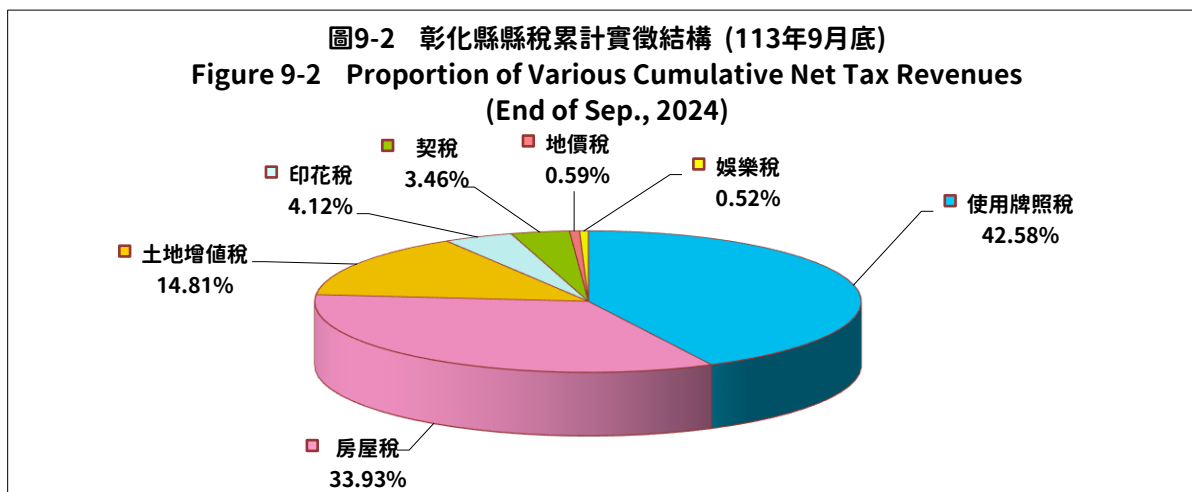
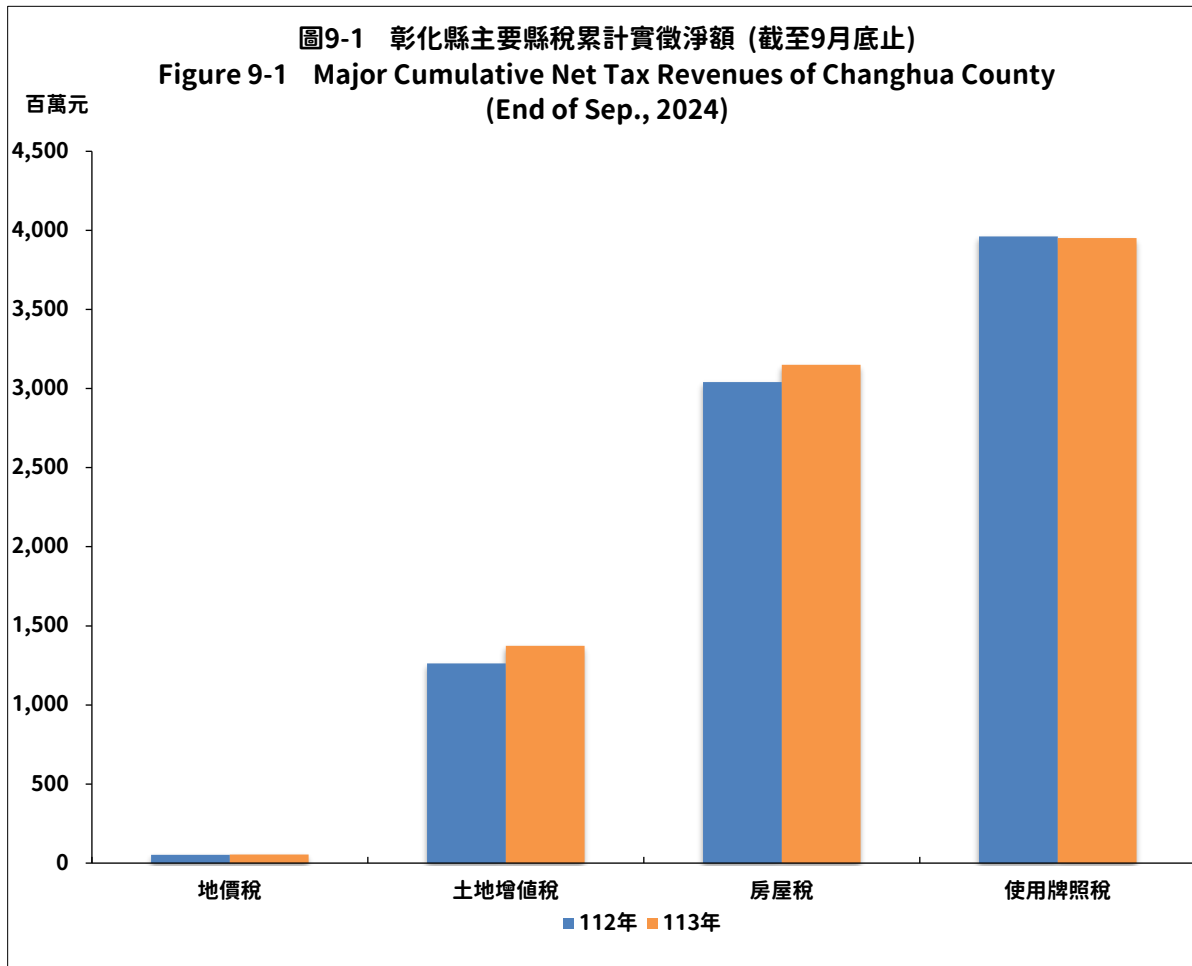
